BIJU PATNAIK AWARD FOR SCIENTIFIC EXCELLENCE

Guidelines :

1. A. The Biju Patnaik Award for Scientific Excellence is the first award of its kind by the Science & Technology Department, Government of Odisha. The award is named as 'BIJU PATNAIK AWARD FOR SCIENTIFIC EXCELLENCE' after the great visionary Biju Patnaik, an illustrious son of the soil. It will be awarded to Odia Scientist working any where in India and abroad each year for lifetime outstanding research contributions in the field of Science & Technology, through the Odisha Bigyan Academy.
- B. Minimum age limit of Scientists should be 60 (sixty) years by 31st December of that year preceding the year of Award.
- C. Branch under the following broad areas :
 1. Physical Sciences (PS) : Physics, Chemistry, Mathematics, Geology, Geophysics, Earth Science, Atmospheric Science and Oceanic Science.
 2. Life Sciences (LS) : Botany, Zoology, Biotechnology, Environmental Science, Bioinformatics, Life Science, Agriculture Science, Horticulture, Fishery, Forestry and related sciences.
 3. Medical Sciences (MS) including Veterinary Sciences and Pharmacy.
 4. Engineering & Technology (ET) including Computer Science.
2. The award comprises a cash prize of Rs. 2,00,000/- (Rupees two lakh only) with citation, certificate, shawl and gold coated silver medallion.

Eligibility Criteria :

3. Persons to be eligible for this award:
Should be Odia by birth or domiciled in Odisha since birth (Attested copy of proof has to be enclosed).

Modalities :

4. Funds for the awards shall be placed with the Odisha Bigyan Academy every year and the Odisha Bigyan Academy shall implement the award.
5. The Odisha Bigyan Academy will invite nominations for the awards through notifications in newspapers, magazines and websites.

The nomination will be from any of the following :

- a. Heads of Research/Academic Institutions of repute, National Laboratories/Universities inside/outside the State, in public or private sector recognized by the Government.
- b. Heads of P.G. Departments in the Universities and Principals of the Colleges inside/outside the State recognised by the Government.
- c. Former Awardees of 'Biju Patnaik Award for Scientific Excellence'.
- d. Fellow of any of the three National Academies i.e. INSA, IASc, NASc.

6. (a) Nominations for this Award shall be submitted in the approved format.
- (b) Each year fresh nomination to be invited. Once nominations for the said Award Year are invited the past years nominations shall be invalid.
7. (a) Two hard copies and one soft copy (in PDF format in a CD) of nomination in prescribed format duly filled in, along with other relevant documents, should be forwarded to the office of the Odisha Bigyan Academy.
- (b) Each nominator should provide a complete list of Publications in standard refereed journals of the nominee. A list of best 10 papers of the nominee along with reprints (both hard copies as well as soft copies in PDF format) must be enclosed.

Selection Procedure :

8. All nominations will be scrutinized by Award Advisory Committee of the Odisha Bigyan Academy.
9. Each nominator should also provide the assessment report of two referees/reviewers of the relevant field in the prescribed proforma (in sealed cover) along with nomination.
10. A panel of Experts comprising minimum 8 members with at least one expert from the major subjects/branches from which nominations have been received shall be constituted by the Odisha Bigyan Academy. The members of the panels should not have been connected with the nominee/ nominator. Each panel shall have a chairperson to be nominated by the President of the Academy.

The recommendations of the Expert Panel shall be submitted with a brief justification thereof in a sealed cover. The Expert Panel shall recommend for one name only. Award will be of Rs. 2.00 lakh with citation, certificate, shawl and gold coated silver medallion. The award may be withheld by the Odisha Bigyan Academy in any year, if, in the opinion of the Expert Panel, no sufficiently meritorious candidate is found suitable in that year.

The Executive Council of the Odisha Bigyan Academy shall finally approve the Award, based on the recommendations of the Expert Panel.

11. A person can avail 'Biju Patnaik Award for Scientific Excellence' once in his/her lifetime. Efforts will be made to announce the award on the Foundation Day of the Odisha Bigyan Academy i.e. 1st April every year.
12. The presentation of the award will be made on a day to be decided by the Science and Technology Department, Government of Odisha.
13. Efforts will be made to request the 'Biju Patnaik Award for Scientific Excellence' award winner to deliver lecture, based on their contributions to Science & Technology at different institutions of Odisha. Funds for organizing the lecture shall be provided by the Odisha Bigyan Academy.
14. The nomination will be summarily rejected if any submitted information is incomplete or found wrong.
15. President/Vice-President/Secretary/Joint Secretary/Treasurer and members of the Executive Council of the Odisha Bigyan Academy shall not be eligible to be nominated for 'Biju Patnaik Award for Scientific Excellence' during their tenures of office.
